How are you doing with your objective of protecting corporate assets? How is your grip over the safeguarding of information assets? We will address the issue of cybersecurity – a different name for digital asset protection- through different angles.

First, this is to embrace cybersecurity as an enterprise process from vulnerability assessment to incident containment. Commonalities with other corporate processes are worth looking at. As a systemic approach is rarely enough, we will also address the human and culture factors.

Second, we will look at the last technologies, and rather on how to handle those. As prevalent factor in the elaboration of cyberdefense, technology can potentially be overwhelming to the executive. The misunderstanding of the role of detection intrusion probes, cloud access security brokers, advanced persistent threats, security operations center, cloud-based automated response systems to name a few can lead to inadequate decisions.

Building on our Korean market practices, we will share our experiences and best practices encountered on the cybersecurity field.
