On June 8, 2020, the appointment process for the next Director-General of the World Trade Organization (WTO), the international organization dealing with the global rules of trade, formally commenced. Following consultations amongst the countries that make up the WTO membership, Dr. Ngozi Okonjo-Iweala is set to become the new Director-General.

She will join a WTO that is under considerable pressure to reform given the limited outcome of its negotiating function and the non-functioning of its Appellate Body. Indeed Dr. Okonjo-lweala indicated the WTO rule book "would greatly benefit from an update to 21st century issues such as e-commerce and the digital economy, the green and circular economies". During this webinar expert speaker with in-depth knowledge about the WTO and its operation will explain the WTO's current situation, assess the future challenges, and discuss about the direction taken by new leadership.
